



MKHONDOCAM CAMERA PROJECT

To Whom it may concern,

Pieties Neighbourhood Watch in conjunction with Agri Piet Retief, Alpha Security, ACSU Security and SAPS Piet Retief are busy with a project to have LPR (Licence Plate Recognitions) and Amadlozi-Cam cameras installed throughout the Piet Retief district.

The Alpha Security Camera network already covers large parts of Mpumalanga and KZN with cameras installed on most major routes from Bethal to Durban and inland up to Utrecht. Paul Pietersburg is currently looking at the option of getting onboard as well. From the Highveld through to the Lowveld including Nelspruit up to Komatipoort is covered by the same Amadlozi Platform. ACSU Security has a long history in Ermelo and has been working with Alpha Security for quite some time and has recently opened a branch in Piet Retief with their reaction unit already having made various arrests since opening the branch.

Over the last few months, you would have noticed that more and more camera poles were being installed all along the district roads by the different Farm Watches in our district. Since the start of the project, we have had numerous successes including the recovery of various stolen vehicles, tracking vehicles involved in criminal activities, as well as tracking a vehicle that was involved in a possible kidnapping, the arrest of the armed robbers that robbed Pick and Pay in town on the 1st of September 2022. We are currently in the process of having cameras installed at the entrance and exit points to Piet Retief town as well as strategic points in town bringing the total number of cameras to 68 in the Piet Retief district by the end of 2022.

We would like to invite all interested parties to get involved with this project to ensure that our district is a safe and as far as possibly a crime free area. We require funding to cover the monthly monitoring fees as well as funding for additional cameras.

(hereinafter referred to as the “Pieties Neighbourhood watch”)

1. RECORDAL

It is recorded that –

- 1.1 The goal is to minimize crime in Piet Retief District and increase security overall; and
- 1.2 Both Parties recognizes the benefit of camera monitoring; and
- 1.3 Security and community safety is a community, business, and personal priority; and
- 1.4 The purpose of the agreement is to augment police/security presence, reduce police/security response time, and deter criminal activity within Piet Retief District; and
- 1.5 For the aforesaid purpose, the Parties agree as set out herein.

2. GENERAL

- 2.1 The Membership holder acknowledges that he/she will have access to the Agri Piet Retief LPR and Amadlozi-Cam camera network through a designated safety representative for the sole purpose of combating and / or preventing crime.
- 2.2 The Agreement is not intended to, nor shall it be interpreted to create or vest any property rights or interests in the Equipment to the Membership holder.
- 2.3 There are no third-party beneficiaries to this Agreement. Nothing in this Agreement is intended to or shall confer upon any person other than the Parties any rights or remedies hereunder.
- 2.4 Where the Membership holder uses the service on behalf of a non-member the Membership holder will become co-liaible for the incident fee as set out below.

4. PROTECTION OF PERSONAL INFORMATION

4.1 Pieties Neighbourhood watch respects your privacy, your personal information and, for this reason, we take all reasonable measures in accordance with our privacy policy to protect your personal information and personal data and to keep it confidential.

5. ACKNOWLEDGEMENT AND DECLARATION

The Membership holder agrees and acknowledges that:

- 5.1 this Agreement permits Pieties Neighbourhood watch to make information available to the third party/ies indicated herein;
- 5.2 Pieties Neighbourhood watch accepts no liability whatsoever for any loss including direct, indirect, and consequential loss, that may arise from any disclosure contemplated herein;
- 5.3 Pieties Neighbourhood watch and the Membership holder agree that this Agreement may be cancelled by either party in writing, by providing **30 (thirty) days'** written notice of cancellation; and

6. PAYMENT

- 6.1 The monthly fee is payable in advance by the Membership holder via debit order to Pieties Neighbourhood watch in the month for the month.
- 6.2 Membership Fees will be revised annually dependant on the number of active personal and business members contributing
- 6.2 If the monthly fee (which was payable in advance) was not paid upon a request or a submission of a debit order against the Membership holder's bank account has been unsuccessful, at the next request for payment, Pieties Neighbourhood watch would submit two debit orders, the unpaid one as well as the one for the new month. If only one was paid, the payment would be used to settle the original outstanding monthly fee.
- 6.3 If on the submission of **2 (two)** debit orders, the fee for **2 (two)** consecutive months have not been paid, the Agreement (and any liability) will be cancelled with retrospective effect.
- 6.4 If the debit order for the monthly fee is returned due to **"dispute"** and the refusal to pay fee(s) emanates from the Membership holder, Pieties Neighbourhood watch is entitled to regard the instruction as an immediate cancellation of this Agreement.
- 6.5 The Membership holder agrees and understand that he/she cannot reclaim any amount(s) which have been withdrawn from his/her account (paid) in terms of this Agreement and debit order mandate if such amount(s) were legally owing to Pieties Neighbourhood watch.
